## **Campofrio Food Group anuncia una oferta de emisión de 500 millones de euros de bonos simples**

**Madrid, 20 de octubre de 2009.-** Campofrio Food Group hace público hoy que tiene la intención de realizar una emisión de 500 millones de euros de bonos simples (senior unsecured notes) con vencimiento en 2016 a efectos de extender el perfil de vencimiento de su deuda más allá del 2013 y de integrar su estructura financiera después de la fusión, tal y como lo anunció el 13 de octubre de 2009.
